Early Childhood Literacy and Mathematics Board Outcome Goals

The percent of 3rd grade students that score "*meets grade level*" or above on STAAR Reading will increase from 35% to 65% by June 2024.

The percent of 3rd grade students that score "*meets grade level*" or above on STAAR Mathematics will increase from 35% to 65% by June 2024.

Reading and Writing Student Outcome Goal (SOG)

The percentage of students performing at or above grade level in reading and writing will increase from 35% to 65% in five years by June 2024.

1. Reading and Writing Growth Progress Measures (GPM)

GPM 1.1 The number of students in grades K-8 "**reading on grade level**" at the end of the year will increase from 35% to 55% by June 2021.

GPM 1.2 The number of students in grades K-2 scoring "**developed**" on TPRI or other reading diagnostics will increase from 35% to 55% by June 2021.

GPM 1.3 By 2021, all individual students in grades 3 through 8 will score "**meets or exceeds**" expectations on Reading and Writing STAAR.

Mathematics Student Outcome Goal (SOG)

The percentage of students performing at or above grade level in mathematics will increase from 35% to 65% in five years by June 2024.

2. Mathematics Growth Progress Measures (GPM)

GPM 2.1 The number of students in grades K-8 "on grade level" in mathematics at the end of the year will increase from 35% to 55% by June 2021.

GPM 2.2 The number of students in grades PK-2 scoring "making progress" on campus formative assessments will increase from 35% to 55% by June 2021.

GPM 2.3 By 2021, all individual students in grades 3 through 8 will score "meets or exceeds" expectations on Mathematics STAAR.

Academic Growth Student Outcome Goal (SOG)

The percentage of students who demonstrate at least one year of academic growth will increase from 35% to 65% in five years by June 2024.

3. Academic Growth Progress Measures (GPM)

GPM 3.1 The number of students in grades K-8 mastering one year or more of growth in reading will increase from 35% to 55% by June 2021.

GPM 3.2 The number of students in grades K-8 mastering one year or more of growth in mathematics will increase from 35% to 55% by June 2021.

GPM 3.3 By 2021, and each succeeding year, all students exiting Pre-Kindergarten will be "Kindergarten ready."
