BOARD TRAINING ANNOUNCEMENT

Under State Board of Education Rule (SBOE), completing required continuing education each year of service is a basic obligation and expectation of any sitting board member.

As Board President, I Cecil Crenwelge, am required to announce the name of each member who as of that member's anniversary of election or appointment to the Board:

- Has **completed** the required continuing education.
- Has **exceeded** the required continuing education.
- Is **deficient** in meeting the required continuing education.

The SBOE requires **seven training areas** of continuing education for Board Members:


1. Local District Orientation (New members)
2. Orientation to the Texas Education Code (New Members)
3. Update to the Texas Education Code (After Regular/Special Sessions)
4. Team building (annually with the entire board and superintendent)
5. Additional continuing Education (10 hours first year, 5 hours subsequent years)
6. Evaluating Student Academic Performance and Setting Goals (every two years)
7. Identifying and Reporting Abuse and Trafficking (every two years)

Other Laws require **three training areas** of continuing education for Board Members:

8. Open Government Act (New Members)
9. Public Information Act (New Members)
10. Cybersecurity Training (annually)

For the reporting period of May 2021 through the date of this announcement Board Members are reported to have "Completed", "Exceeded", or are "Deficient" in each Training Area One through Ten (1-10) on the **attached continuing education record**.
